He reported that this new funding would enable the district to prepare a balanced budget 2009-2010 and avoid any layoffs of classified or certificated employees. He pointed out that because of one time monies available to help balance the budget, the prognosis for the 2010-2011 fiscal year is not good. A huge financial cliff has been created with a projected deficit of \$2 million. Early planning will be necessary and some very difficult decisions will have to be made.

Orlando Johnson, Business & Support Services Director provided a power point presentation regarding the Base Revenue Limit Reductions, New and Reallocated Funds for 2009-2010, Transportation Savings Options and Proposed Reductions for the 2010-2011 fiscal year.

Dr. Budde informed the board that he is working on establishing a Strategic Planning Committee made up of certificated, classified and community people to discuss options. Round table discussion was held regarding budget concerns and how these would affect the district.

Trustee Walker recognized SANDY MONTALVO for being selected as recipient of one of two State CIF Distinguished Service Awards from the San Diego CIF Section for the 2008-2009 school year. Sandy reported that the award was presented to her at a recent Board of Managers meeting in San Diego as well as a CIF Gold Courtesy Pass.
