The Superintendent reviewed the information provided by Caldwell Flores Winters, Inc. in response to the board's interest in reviewing the specific questions used for the voter poll survey regarding a future bond measure.

ECSTA AND CSEA COMMENTS:

Dennis Price, ECSTA President reported on the following items:

Expressed concern over the leasing out of the Southwest Performing Arts Theater and classrooms to a local church organization and the supervision of volunteer workers.

Candidate Forum is scheduled for 9/23/10 from 6:00 – 8:00PM at the District Office board room.

ECSTA would be web-casting some upcoming football games. He expressed concern over the District's web site not working. Links seem to disappear and it does not appear to be user friendly. He suggested that the full agenda be posted along with other pertinent budget reports.

Expressed concern over the ending balance reported in the revised budget report earlier approved by the board. Stated that the negotiated MOU to increase class size by six students was engineered to protect the continued employment of all counselors. The decision was based on financial information presented to the ECSTA negotiating team which he now questions. Trustee Jimenez suggested he meet with district office staff to review budget information.

Requested to be part of the District Leadership Team in order to be better informed of decision made affecting the district. He also reported that work is underway to hold a "Pump my Car" raffle to recognize students who excel on the CST's.

Stated the position of ECSTA regarding the board vacancy would be to wait until after the November election and then appoint the candidate that comes in third place. Trustee Jimenez responded that because of specific timelines related to the filing of a vacant board seat that was not possible.
