## First Interim Report 2017-18

### Narrative

The California Education Code (Ed Code) requires school district governing boards to approve and certify four financial reports each year. These financial reports are: First Interim (covering July 1 through October 31) Second Interim (covering July 1 through January 31) and Estimated Actuals (covering July 1 through June 30) and Unaudited Actuals. These reports must be prepared using the Standardized Account Code Structure (SACS) software developed by the California Department of Education.

Based on the financial information presented, the Board must make one of three certifications:

- Positive Certification: Designation means the District can reasonably expect to meet its obligations for the current year and subsequent two years.
- Qualified Certification: Designation means the District may not be able to meet its obligations for the current year and subsequent two years.
- Negative Certification: Designation means the District is in danger of not meeting its obligations for the current year and subsequent two years.

The format for the First Interim Report meets the Ed Code requirements. The first pages of the fund documents identify revenues and expenditures at a summary level of information followed by additional documents that disclose the details behind the revenues and expenditures. The Central Union High School District's First Interim Report is submitted with a Positive Certification.

### **First Interim Report - Budget Overview**

In order to develop the District's First Interim Report, a series of assumptions must be determined about the conditions of the District as well as the State's budget perspective. These assumptions are then inserted into State and District formulas in order to determine what to modify in the Budget. During the year, the District will present two additional budget reports to the Board of Trustees which are essentially updates to the Budget. The First Interim Report is presented in December and includes these major pieces:

1. A narrative regarding current fiscal considerations, budget assumptions and budget projections for the upcoming fiscal year.
2. The state-required Standardized Account Code Structure (SACS) budget report forms, which include a variety of financial facts and figures

### **State Information**

In January 2017, the Governor's proposed 2017-18 Budget provided an increase to ongoing education funding closing the remaining Local Control Funding Formula (LCFF) gap for 2017-18 by 23.67%. In the May Revise Budget, the Governor proposed to increase the LCFF gap funding to 43.97%. Ultimately, the final gap percentage increase to the LCFF was released when the Governor signed the State Budget. The final LCFF Gap percentage for 2017-18 is 43.19%. As the State continues to aggressively fund the LCFF gap, future funding for districts will greatly diminish as they get closer to their LCFF Target Funding. Although, there is speculation that, given the healthy financial projection from the Legislative Analyst Office (LAO), the Governor may move forward with fully funding the LCFF for districts.

The Governor's 2017-18 State Budget provided an additional \$1.4 billion for education based on unanticipated State revenues for 2015-16, 2016-17 and additional projected revenues for 2017-18. The enacted 2017-18 State Budget provided \$74.5 billion for education which is up from \$71.4 billion in 2016-17. As part of this additional funding, the Governor provided another round of one-time funds for discretionary purposes. The \$877 million of one-time funds will be distributed based on Average Daily Attendance (ADA). An issue not addressed in the State Budget is the continued concern of increased retirement costs for CalSTRS/CalPERS.

### **Local Control Funding Formula (LCFF) & Local Control Accountability Plan (LCAP)**

One of the main principals of the LCFF funding model is to target funds towards meeting the needs of disadvantaged students that are identified under the following three categories: English Language Learners, Low Income Students (pupils eligible for free and reduced price meals), and Foster Youth. The targeted students are referred to as unduplicated pupils under the LCFF. The percentage of unduplicated students enrolled in our District averaged over the current and last two years is 75.64%. This is our current three year average of unduplicated students which included our October CALPADS enrollment snapshot on October 4, 2017. The District will certify the final count on December 15, 2017.

The targeted funding for the unduplicated students are called Supplemental and Concentration Grant Funds and is based on the percentage of unduplicated students identified in the three categories stated above. Districts are to target these particular funds on actions and services based on the Local Control and Accountability Plan.

The Local Control and Accountability Plan and Annual Update or what is commonly known as LCAP is the accountability mechanism of the LCFF and is a planning tool that delineates how the district will meet identified needs, specified goals, and lists the services and actions necessary towards achieving those goals.

The main principal of the LCAP is to show **how** the district will provide increased or improved services to English Learners, Low-Income and Foster Youth students under the supplemental/concentration grant. The proposed 43.19% gap funding for 2017-18 is included in the Governor's State Budget. The Minimum Proportionality Percentage (MPP), which is the percentage by which services for unduplicated pupils must be increase/improved as compared to all pupils being served, has been established at 22.34%. The targeted funding estimated for Supplemental and Concentration Grant Funding in 2017-18 is \$7.8 million.

### **Enrollment/Attendance - History and Projections for 2016-17**

The most significant characteristic for determining a district's State revenue is the calculation of the average number of students that are in attendance on a daily basis through-out the school year. The State does not pay the District for enrollment but on actual student attendance. The Local Control Funding Formula will not generate State funding unless the student attends school. The October 4, 2017 CALPADS enrollment snapshot is 4,189. The District's enrollment for 2016-2017 was 4,119. This is an enrollment increase of 70 student or 1.7%.

ADA (average daily attendance) is the most important part of the District's income as this funding accounts for **96.3%** of the total funding for the Unrestricted General Fund. Even small fluctuations in the District's ADA can mean tens of thousands of dollars as a gain or loss in revenues. The District's attendance records are monitored monthly and ADA is reviewed throughout the year to ensure maximum State funding and to monitor projected revenue within budget. A 1% fluctuation in district attendance equates to a gain or loss of approximately **\$424,000**. The District's ADA percentage to enrollment for 2016-17 was **95.38%**. The 2016-17 State-wide ADA percentage for High School Districts was **94.05%**.

The projected ADA for 2017-18 is based on using a four year average attendance percentage times our 2017-18 CALPADS enrollment figure of 4,189. Although our current enrollment count is higher than last year, the District will continue to budget State LCFF funding based on prior year's (2016-17) P-2 ADA of 3,928.80. The graph in Table 1 below provides an illustration of the ADA-to-Enrollment history for the Central Union High School District that includes the 4,189 enrollment figure with projected ADA at 3,976.17.

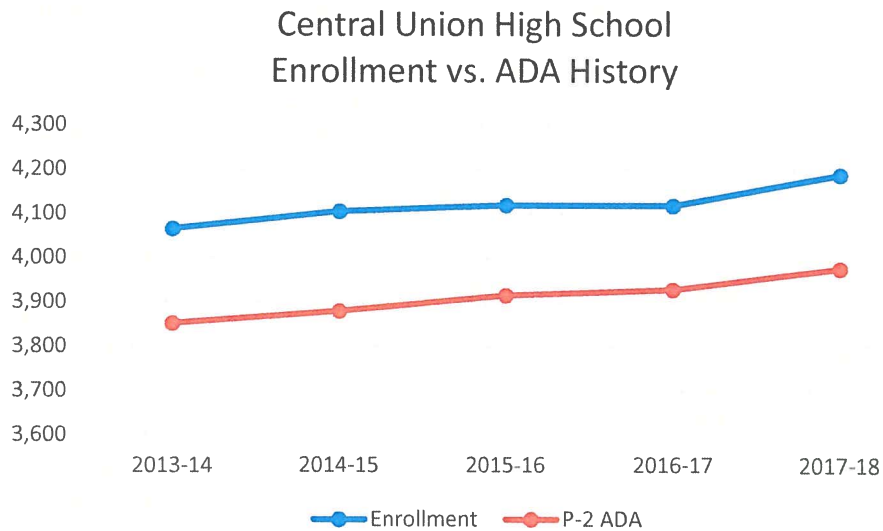

## **FIRST INTERIM 2017-2018 - VARIANCE REPORT**

*The Central Union High School District's First Interim Report is based on actual revenues and expenses through the fiscal period ending October 31, 2017. The variance analysis compares revised projected budget information through June 30, 2018 against budget data in the approved budget presented to the Board of Trustees in September, 2017.*

### **UNRESTRICTED GENERAL FUND**

#### **REVENUE VARIANCE**

1. LCFF funding increased by \$146,431 or 0.3%. This increase is attributed to updating the District's Local Control Funding Formula calculator with the October 4, 2017 snapshot information pertaining to unduplicated pupils. The unduplicated pupils for 2017 is 77.7%.
2. Federal and Other State Revenues remained constant.
3. Other Local Revenue decreased by <\$182,762> or -44.4%. The decrease to this category was due to an adjustment to the California Clean Energy account. Projected funding for this grant program has been shifted to the restricted side of the budget.

*Overall Unrestricted Revenues decreased by \$36,331 or 0.08%*

#### **EXPENDITURE VARIANCE**

1. Certificated Salaries decreased by <\$399,193> or -2.0% compared to the September Budget. This decrease is primarily due to salary cost adjustments. There was an adjustment to 6<sup>th</sup> Period assignments based on requests submitted. Additionally, budgeted counselor salaries were adjusted based on individual employee's pay information.
2. Classified Salaries increased by \$472,547 or 8.7%. This increase is attributable to budget adjustments to classified salaries based on the bargaining unit agreement for 2017-18. This increase is also based on increases to classified management, supervisors and administrators as approved by the Board on November 14, 2017.
3. Employee Benefits increased by \$102,489 or 1.3%. The budget was updated to include adjustments for the negotiated salary increases.
4. Books and Supplies increased by \$74,449 or 3.5%. This decrease is attributable primarily to adjustments on various items included in the Local Control Accountability Plan. Other increases include \$30K for dual enrollment textbooks and \$19K for College & Career Readiness Initiative.
5. Services and Other Operating Expenses increased by \$83,383 or 2.5%. The budget was increased to accommodate an increase to IVROP services for Career Readiness courses. Other adjustments include various items based on the Local Control Accountability Plan.
6. Capital Outlay – no change. Remained constant.
7. Other Outgo increased by \$5,387 or 0.9%. This is due to an adjustment to the students generating "District of Resident" funds for ICOE. The transfer to ICOE increased slightly based on student unduplicated % increase.
8. Transfers of Indirect Cost increased \$335,863 or 206%. This increase is a result of adding Cafeteria Indirect, additional CTE Incentive Grant expenditures, Special Education expenditures, and new ROP Learning Community Grant expenditures.

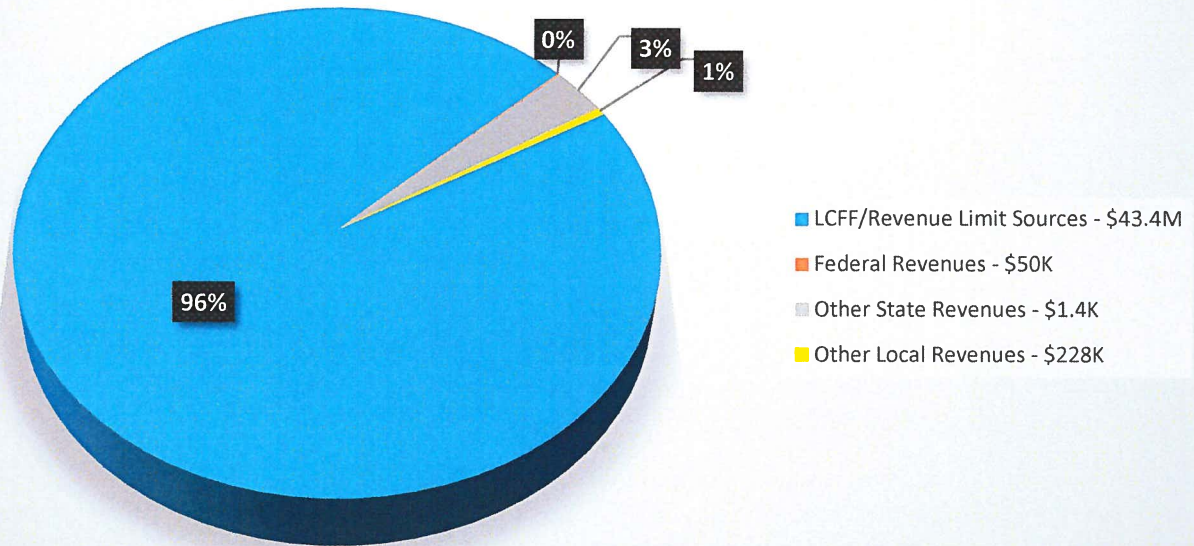
*Overall Unrestricted Expenditures increased by \$3,199 or 0.008%*

Other Financial Sources/Uses category increased by \$75,304 or 1.7%. The District is requesting to transfer Adult Education CalWorks funds to the Adult Education Fund which were originally deposited in the General Fund by the County Office of Education.

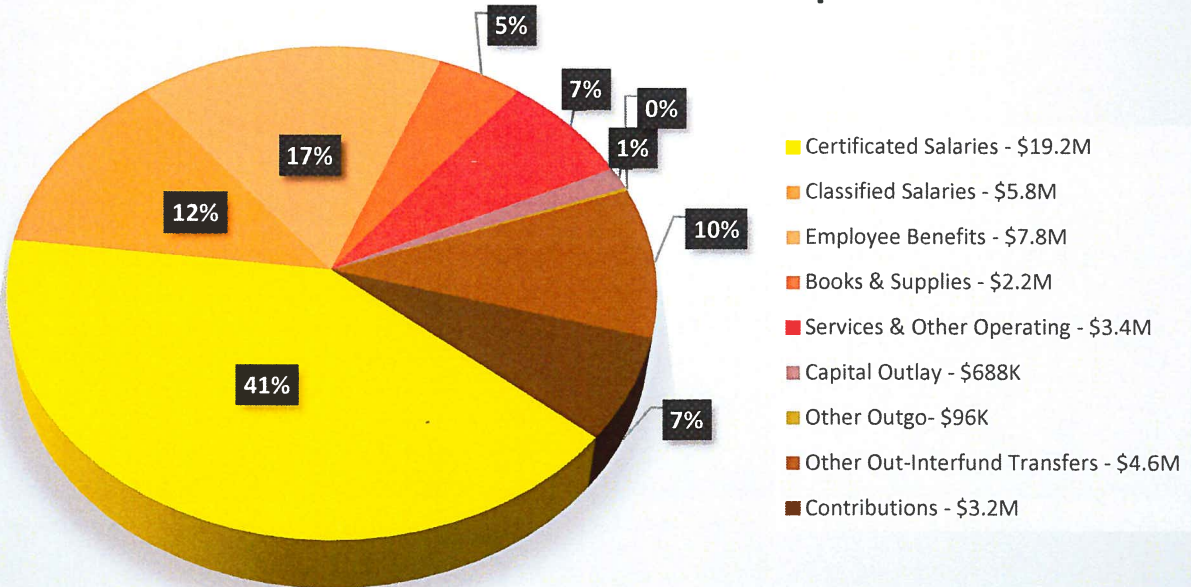
The Contributions category also increased by \$124,735 based on additional budgeted expenditure in Special Education and the Routine Restricted Maintenance account.

## **RESTRICTED GENERAL FUND**

### **REVENUE VARIANCE**

1. Federal revenues increased by \$82,944 or 3.0%. This minor decrease is due to updating program revenue budgets based on the latest award letters. Basically, Migrant Ed. and Title I funding information.
2. Other State revenues increased by \$270,209 or 6.1%. Along with other minor adjustments, this increase was primarily due to adding the new ROP Learning Community Grant. Also added was carryover grant funds from the California Career Pathways Trust.
3. Other Local revenue increased by \$39,240 or 4.9%. This is a result of a slight increase in Special Education funding.

*Overall, Restricted Revenues increased by \$392,393 or 4.9%*

### **EXPENDITURE VARIANCE**

1. Certificated Salaries increased by \$36,984 or 1.4%. This increase is primarily due to adding the new ROP Learning Community Grant salaries but also extra period assignments in Title I. The budget also had off-setting budget decreases in Title I and Special Education. .
2. Classified Salaries increase by \$86,824 or 5.3%. This increase is predominantly due to the negotiated classified salary increase based on the CSEA settlement for 2017-18.
3. Employee Benefits increase by \$56,816 or 2.0%. The budget was updated to include the adjustments for certificated and the negotiated classified salary increase as noted above.
4. Books and Supplies increased by \$132,394 or 8.1%. The increase is primarily due to proposed expenditures for the Career Technical Education Incentive Grant Program (CTEIG), Title I and Routine Restricted Maintenance.
5. Services and Other Operating Expenses increased by \$494,657 or 54.5%. This increase, again, is mainly due to adding projected expenditures for the CTEIG Program but also new expenditures for the ROP Learning Community Grant.
6. Capital Outlay decreased by <\$148,172> or 15.6%. This decrease is specifically due to a downward adjustment to the CTEIG Program expenditures in this category.
7. Other Outgo - budget is constant. No changes.
8. Other Outgo Transfers of Indirect Cost increased by \$230,863 or 141.1%. This increase is a result of anticipated increase in Restricted program expenditures

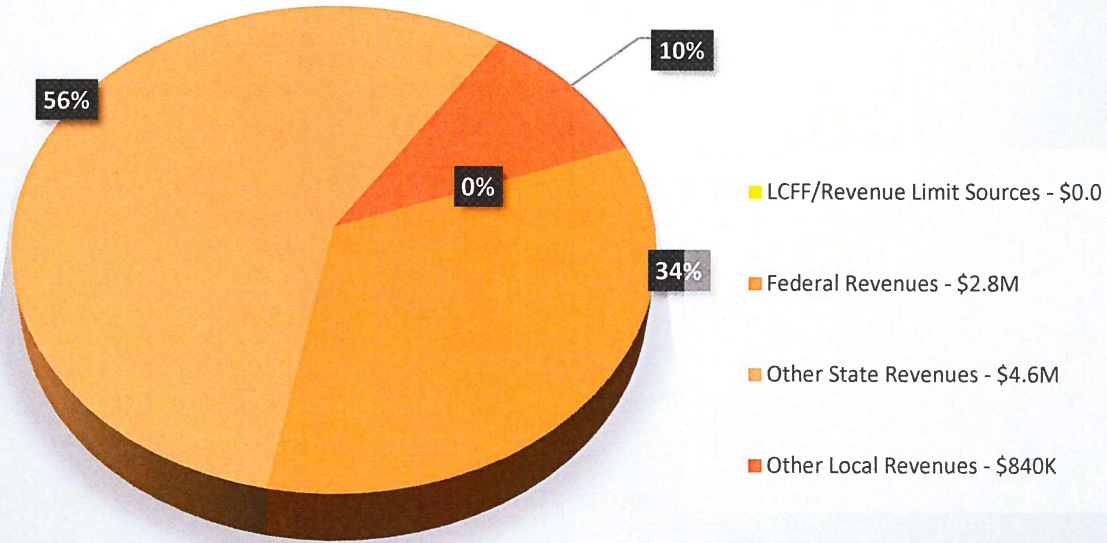
*Overall Restricted Expenditures increased by \$885,976 or 7.9%*

Contributions to the Restricted budget increased by \$124,736 or 4.1%. This is based on additional budgeted expenditure in Special Education and the Routine Restricted Maintenance.

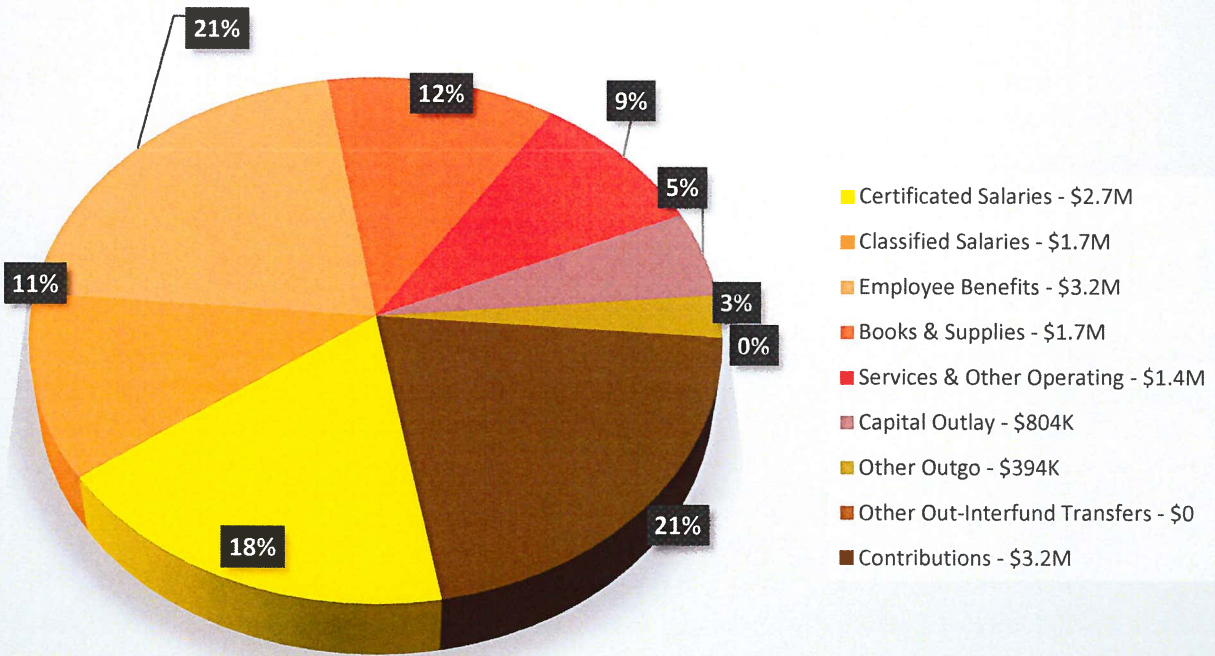


The following pie charts are illustrations of each revenue source and expenditure category by amount and percentage as part of the Total Restricted General Fund Budget.

## **RESERVES**

At this time, the District is projecting a decrease in the Unrestricted General Fund reserves by <\$2,074,890> for 2017-2018. The District is also anticipating a deficit in the Restricted Ending Fund Balance by <\$520,514>. The total General Fund Ending Fund Balance projected at June 30, 2017 is \$12,181,018 for which \$776,041 is designated as Restricted Ending Fund Balance.

## **MULTIYEAR FINANCIAL PROJECTION**

The 2017-18 Multi-Year Projection (MYP) for the First Interim Report reflects that the district will be able to maintain the minimum 3% Reserve for Economic Uncertainty through 2019-20. Any negotiated salary increases, health and benefit increases and any other possible costs during the next two years will have an impact on out-year ending fund balances. The multi-year financial projection assumes that the district will continue to operate at the same level with ongoing costs that are currently in place.

Currently, it is projected that the District will have a deficit in the next two years. A major factor to consider that will affect these future balances would be the elimination of one-time discretionary fund revenues and Mandated Cost Reimbursement dollars (\$806,385). At this time, it is not anticipated that the Governor will continue to provide one-time discretionary dollars for 2018-19 and beyond. Additionally, expenditures in the out years include the STRS and PERS percentage increases which are estimated to be \$629,641 and \$523,870 for 2018-19 and 2019-20, respectively. The District's projection for 2018-19 will be revisited once the Governor's proposed 2018-19 Budget is released in January 2018. At that time, budget modifications, if necessary or required, will be made and included with the District's Second Interim Report.

## **CONCLUSION**

Overall the District's fiscal position is stable. Based on the Department of Finance's projected revenues for future years, the Local Control Funding Formula is expected to provide the District with the means to sustain its current operations and meet educational needs. The Legislative Analyst's Office forecasts surpluses in the State's budget over the next several years. The surpluses assume that spending is flat; an assumption that may be a temptation for the Legislature to spend. In the interim, we must continue to be prudent as the Local Control Funding Formula continues to be rolled out.

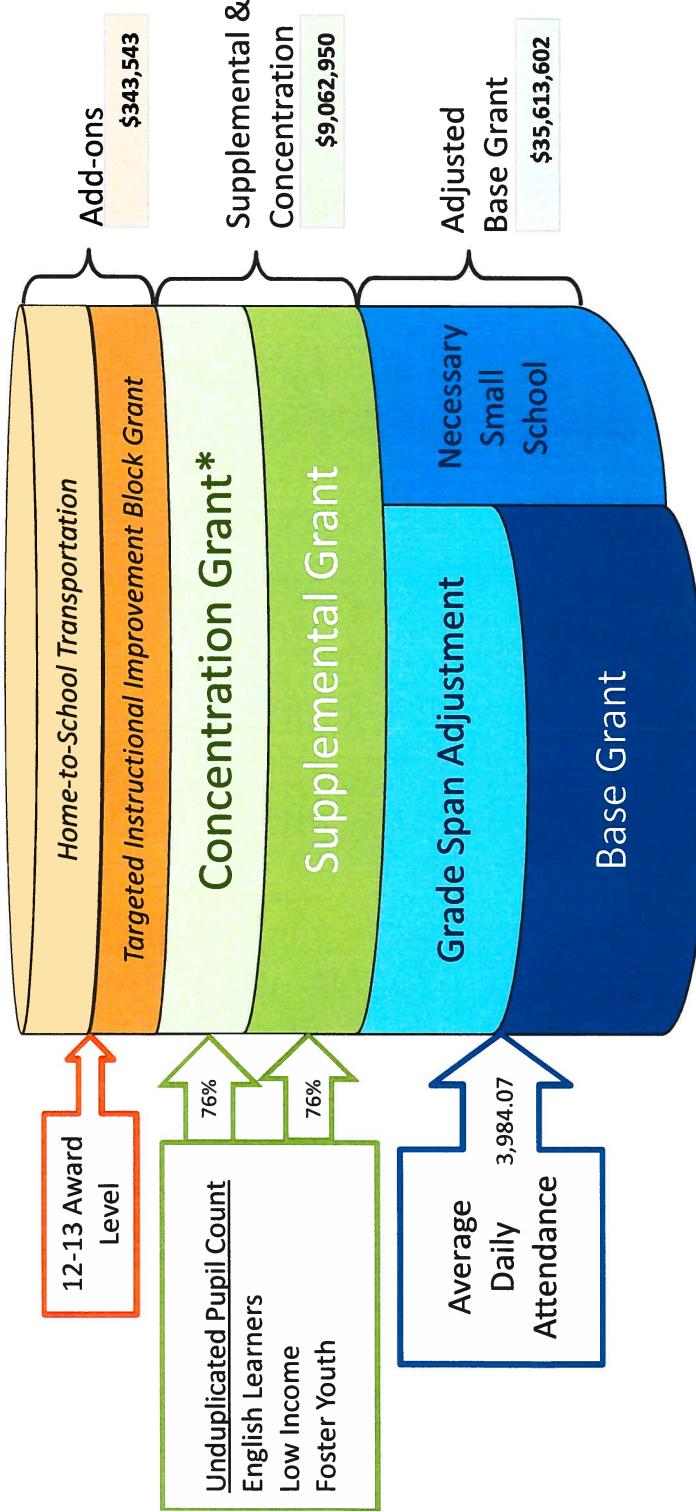

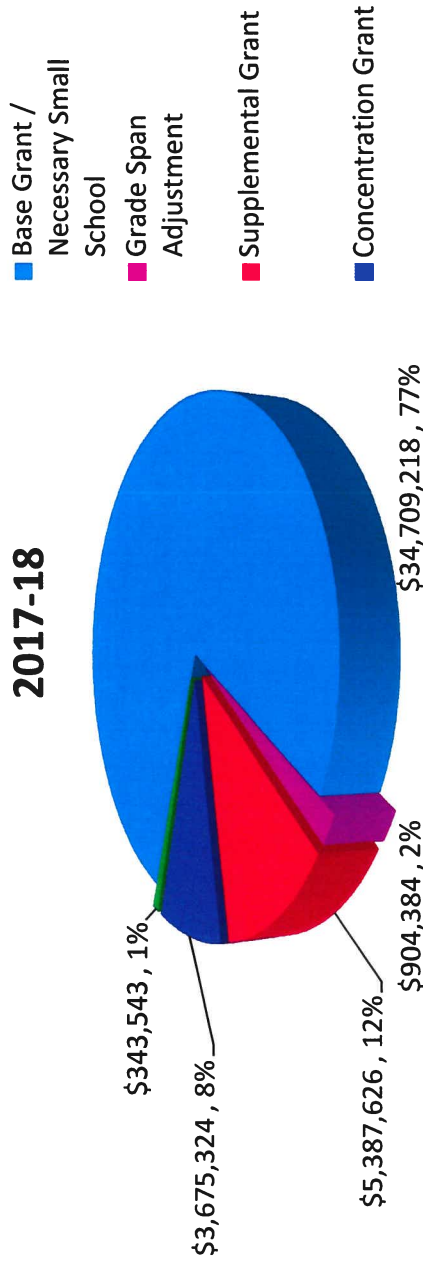

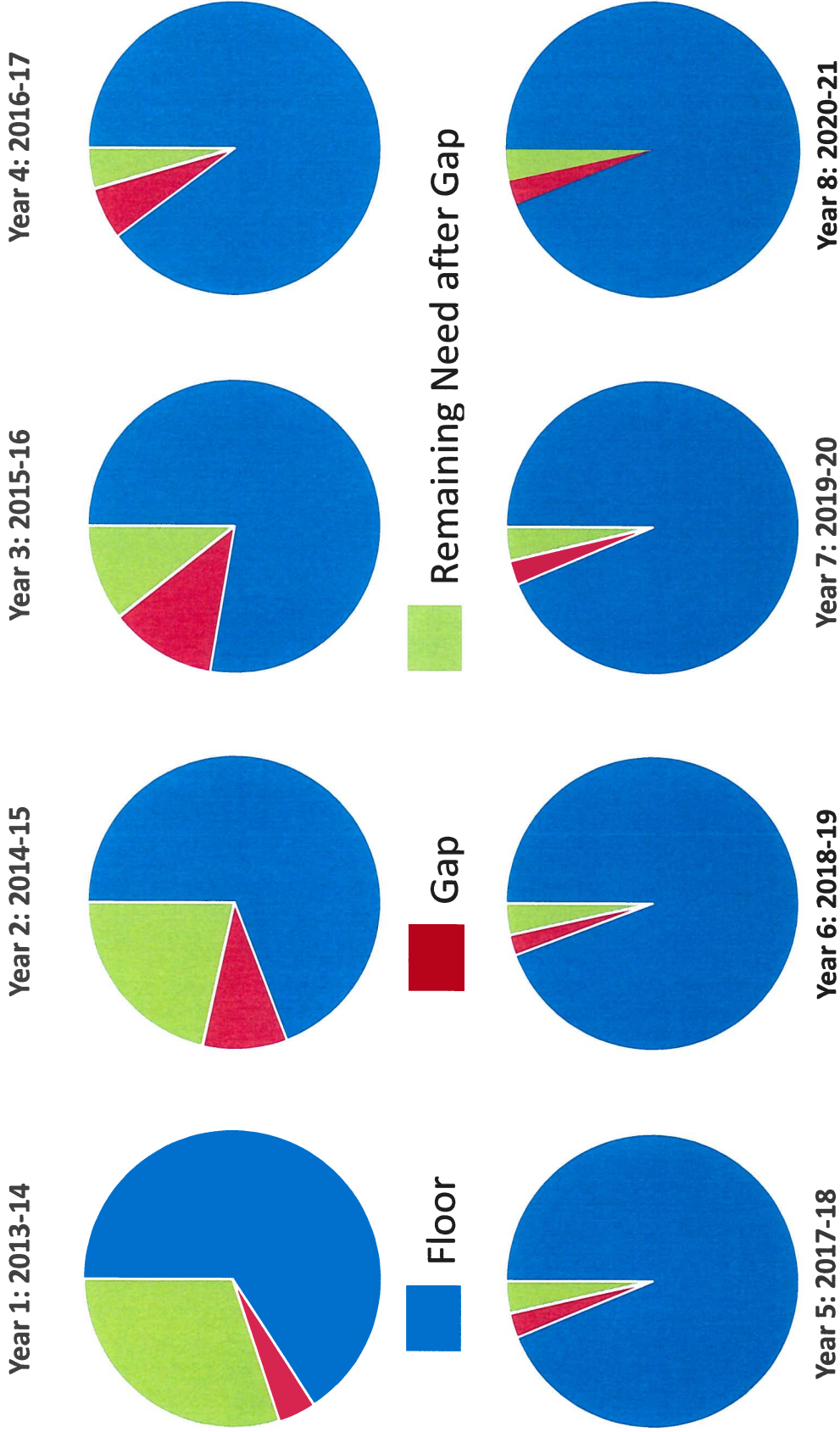

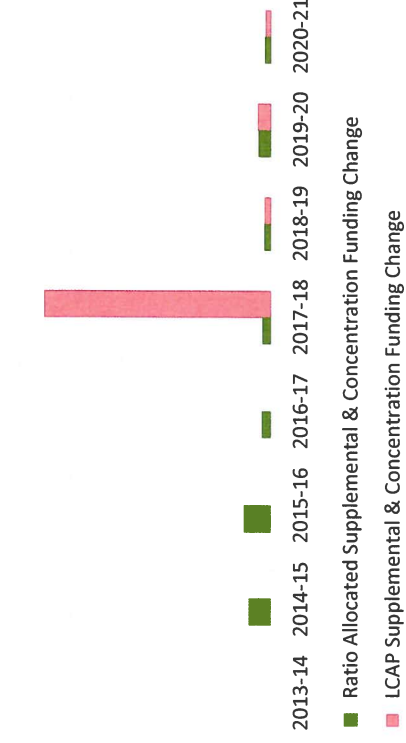

Change in Allocated Supplemental & Concentration Funding



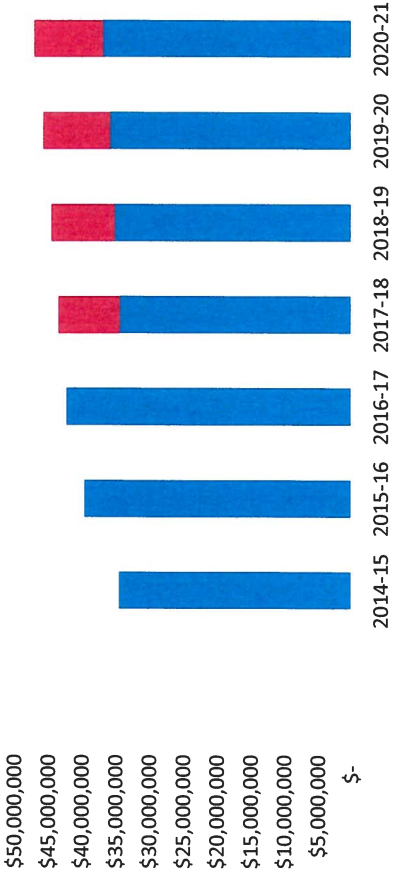

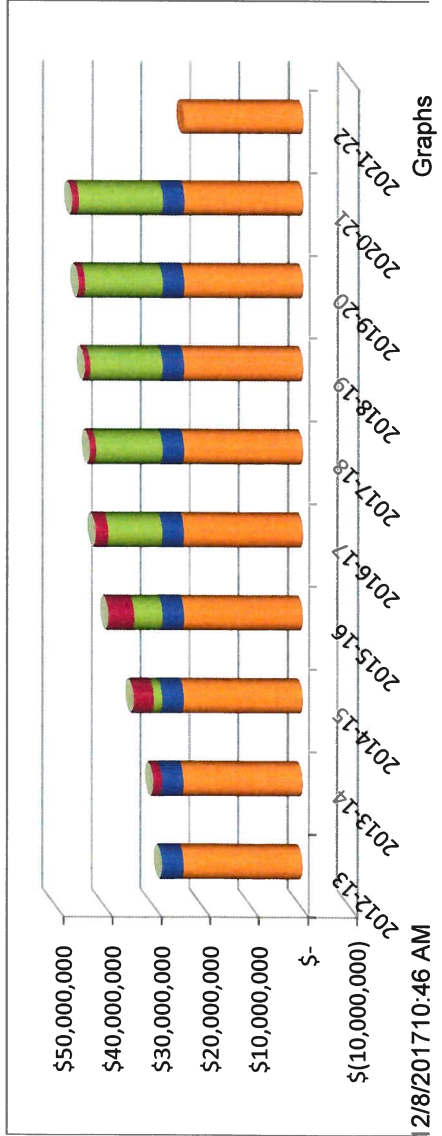

We have updated the cost-of-living adjustment (COLA), Consumer Price Index (CPI), and ten-year T-bill planning factors per the latest economic forecasts. We have also updated the Local Control Funding Formula (LCFF) factors. We rely on various state agencies and outside sources in developing these factors, but we assume responsibility for them with the understanding that they are general guidelines.
